Strategic Plan Review:

Opportunities:

- Possibility of assistance through local governments to provide assistance with new facility as part of an inclusion package with new development and funds through development corporation, or economic development fund
- Better office space could led to more staff/volunteers being interested in WCRC
- Lumby is growing therefore there will be the need to increase our services
- Social Enterprise Opportunities: Possible expansion of 0-6 programs.
 - There is a growing population of young professionals moving to town, who will eventually be starting families, currently only have one program for families with children 0-6 and currently do not have trained staff for Nobody's Perfect Parenting or Parenting Isn't Easy.
- Employee Assistance Programs, etc
- Policies and Procedures are in place but need to be reviewed/updated (added from Feb.Board meeting from Strengths)
- Reduce the stigma about coming into the Whitevalley office.
 - Although WCRC does many programs other than counselling, there is a fear in a small town accessing our office because they don't want people to know they are either seeking services or if they aren't people thinking they are.
- Continue to connect with local organizations to share information about programs available with our agency and the community. Look to increase social media presence as well.
- Health and Safety Health and Safety Committee continues to monitor the health and safety of the working environments and training for staff to be educated on the steps how to deal with client behaviours.

Threats:

- Retention of staff due to wages.
- Client behavioral issues, volatile situations with mental illness, drug addictions, anger issues and no training on how to handle or intervene especially if having to deal with issues outside of the office
- Challenges recruiting staff
- Being an agency in a small town there are concerns about the anonymity/privacy of their information for services they seek.
- Security of long-term funding- suggested by Christine

RCMP -

- 54 files in February, just under from last year. Spencer is done at end of month, won't be replaced until end of summer. Shaun will continue to be our Board representative.

Community Updates

Seniors: Breakfast program was a little cranky and spoke with them about the importance of the program promoting socialization. Try to limit the amount of take-out/delivery breakfasts there are.
